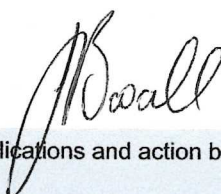

No invoice / supporting document was seen for the diagnostic on the old laptop £36.

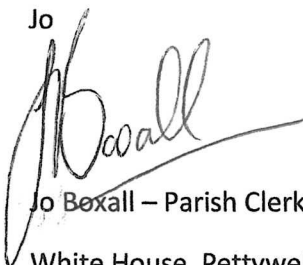
The Clerk was awarded a pay increase February 2023. I could not see any indication of when this pay increase was awarded from and no salary calculation provided to support February payment to Clerk & HMRC.

The Annual Review of the Effectiveness of Internal Control which was reviewed May 2022 states *that 'A councillor shall review the clerk's bank reconciliations quarterly, including at the year-end, and shall sign the reconciliation as evidence of this check.'* I acknowledge that the minutes reflect that the cash book and reconciliation are emailed to Councillors ahead of each meeting, but cannot see any evidence that the reconciliations are signed.

At the time of carrying out the audit the bank statement provided for the Business Premium Account was up to 14th March 2023.
